Part-A (100 questions) English, Hindi

Part-B (100 questions) General knowledge/ general studies

Each question will carry two marks. No candidate shall be deemed to have qualified for the viva-voce unless he obtains a minimum of 33% marks in each part and a minimum of 40% in the aggregate. However, as per law laid down by the Hon'ble Apex Court, candidates equal to three times of the number of vacancies will be called for interview based on their performance in the written test. The total marks obtained in the written test and viva-voce will determine the final merit of the candidates in their respective General/Reserved categories. Viva Voce will be of 50 marks.
