b) To make the entire process of the physical measurement test tamper proof, fair and impartial, both mechanical and digital stadiometers properly calibrated to measure the correct height of candidates exact to the millimeter will be used to the extent possible, in a manner that the candidates are able to read their measurements on a digital display monitor.

c) The result of physical measurement test shall be prepared by the Haryana Staff Selection Commission. The Haryana Staff Selection Commission shall display the same on its official website i.e. www.hssc.gov.in.

d) The candidates who fail to meet the standards prescribed for Physical Measurement Test shall stand eliminated from further selection process.

e) Only the candidates who qualify the standards prescribed for Physical Measurement Test shall take part in the further process of Selection.

**Note:** - Physical Measurement Test shall be of qualifying nature only.

## IMPORTANT INSTRUCTIONS TO THE CANDIDATES FOR PHYSICAL MEASUREMENT TEST

- 1. Candidates must go through the instructions below as well as prescribed on the Admit Card carefully before coming for the Physical Measurement Test (PMT).
- 2. Candidate must bring legibly printed Admit Card with recent coloured photo, pasted on admit card at mark B duly self attested and one identity proof in original with photo like Driving License, Voter Card, Aadhar Card, Passport etc. at the PMT site failing which the candidate will not be allowed to enter for PMT.
- 3. The Admit Card is provisional and subject to fulfillment of advertised eligibility conditions on the cutoff date. The candidate should ensure that he/she possesses the requisite qualifications and age etc. and fulfils all the eligibility conditions for the said post as per advertisement on the cutoff date. In case, at any stage, it is found that candidate does not fulfill the essential eligibility conditions, his/her candidature shall be immediately cancelled without assigning any reason or notice besides taking such other action as deemed appropriate by the Commission. No claim/compensation shall be admissible in this regard.
- 4. Candidate should report the venue alongwith his/her admit card as originally downloaded (not to be photostated) from Commission's website i.e. <a href="www.hssc.gov.in">www.hssc.gov.in</a> at the date and time mentioned therein. Entry in the venue shall not be allowed before the time mentioned in admit card. After the completion of one shift, the entry for next shift shall start.
- 5. Result of Physical Measurement Test (PMT) will be displayed on Commission's website. Candidates who qualify the PMT will only be allowed to take part in further process. Candidates are advised to check the website of Commission for result or for any other update.
- 6. At the venue, candidate shall be given token number and then he/she shall go into the waiting area from where he/she shall be called as per his/her token number for registration.
- 7. Taking drugs and other restricted medicine are strictly prohibited during Physical Measurement Test (PMT).
- 8. All the candidates who have applied for the post, should ensure that they meet the physical standards for the post and fit for the conduct of physical test.
- 9. Written Exam and PST will be conducted for only those candidates who have qualified PMT and whose Roll number is there in result published by HSSC. As per Advt. conditions, after taking biometric attendance, Videography of candidate will be done. Then candidate will appear before the committee assigned for PMT. PMT will be carried out using machines in which data related to measurement will be displayed on screen. Candidate shall sign on the measurement slip. If any candidate has any objection regarding PMT, he/ she shall raise his/ her objection immediately in Grievance Committee of HSSC, after which no such objection shall be considered. Measurements of such candidates for their convenience shall be re-conducted on same day in terms of directions of Hon'ble High Court issued in CWP No. 21841 of 2021 (O&M) titled as Aman vs State of Haryana & Ors. and CWP No. 22985 of 2016 titled as Raghvir Singh & Ors. vs State of Punjab & Ors.
- 10. After checking the Admit card and Photo ID proof of candidate he/she will be allowed to appear before the assigned committee for PMT. After being verified by committee, his/her signature and thumb impression will be taken on the attendance sheet.
- 11. All candidates are bound to follow the instructions given by HSSC and if not followed, his/her candidature may be cancelled.
- 12. If any candidate is found creating any kind of indiscipline, his/her candidature may be cancelled.
- 13. Mobile phones or any kind of electronic instruments are strictly prohibited at the test site.
- 14. Physical Measurement Test (PMT) will be as per HSSC Advt. No. 03/2023 which is already available on Commission's website i.e. <a href="www.hssc.gov.in">www.hssc.gov.in</a>.
