3. Waiting list for Sr. no. 01 has been prepared in view of Chief Secretary to Govt. of Haryana Instructions issued vide leter no 42/02/2017-2GSI dated 18.09.2018.

4. The result of SBC/BC(C) category has been withheld as per letter No. 42/187/2015-5GSI Dated:25.08.2016 issued by Chief Secretary, Government of Haryana in view of directions of the Hon'ble High Court that no appointments in service shall be made on the basis of the provision of the Haryana Backward Classes (Reservation in services and admissions in educational insitutions) Act 2016 to the castes mentioned in schedule-III i.e. Backward Class Block 'C'. The SBC/BC(C) Category candidates, except those who have availed the benefit of age relaxation,have been considered against general vacancies
