E-TENDER NOTICE

For and on behalf of the Haryana Staff Selection Commission, Panchkula, E-tender is hereby invited for empanelment on non-exclusive basis for hiring of private vehicles as per requirement for examination purpose from reputed agencies having work experience of minimum three years for exam process or similar activities etc. in Central Government, State Government/Semi Government/Board/ Corporation/ Universities/Public Undertaking/ recruitment agencies, Universities and any reputed/Private Institutions. The tenderer should have ESI, PF, PAN and GST No. which should be mentioned in the technical bid. If a tenderer does not mention these in his bid, he shall not be considered and shall be deemed to be ineligible. The examination can be held anywhere in the State of Haryana, Delhi and Chandigarh. The tender shall include Technical and Financial Proposal. Rate of applicable GST be also separately mentioned. Agency should quote the rates as per minimum and maximum kilometers and AC and non AC vehicles separately. Rates should be quoted including all permit/taxes/toll tax etc.

TERMS & CONDITIONS :-

1. The firm/Company/Person should submit their rates along with a EMD of Rs.1,00,000/- (Rupees one Lakh only) through online payment on or before 23.01.2023 upto 11.00 AM.
2. The agency will provide Maruti Deszire/Etios/Innova/Tavera and Tempo Traveler 14/17 seater vehicles of 2018 or above models on demand basis.
3. Vehicles should be registered as taxi by the registration authority and should have permit for Haryana, Delhi and Punjab.
4. Vehicle should have valid insurance during the contract period.
5. Parking and toll tax will be borne by the agency.
6. The timing and distance of the taxi will be calculated from Commission office to office return.
7. Area of operation of vehicles Haryana, Chandigarh, Delhi and Punjab.

8. The agency will arrange another vehicles immediately if break down occurs in the existing vehicles at any place at its own cost.
9. Any challan fine due to the negligence of the driver or incomplete documents will be the responsibility of the agency.
10. The agency will be responsible for all kind of work & conduct of driver.
11. The agency will quote rates of AC/Non AC vehicle separately.
12. The agreement will be executed for one year which can be extended for further one year or six months period on mutual consent.
13. The Commission reserves the right to cancel the contract any time without assigning the reason.
14. The firm whose tender will be accepted shall also be required to deposit a security amount of Rs. 2,00,000/- (Rupees two Lakh only) in favour of Secretary, Haryana Staff Selection Commission, Panchkula in the form of bank guarantee which may be forfeited by Commission in the event of not carrying the work as per term & conditions of agreement.
15. Commission may call for upto 40 vehicles at a time which the agency shall have to provide at a short notice of one day and if the agency fails to supply the same, the vehicle shall be hired at risk and cost of the agency.
16. Details agreement for the purpose including penal clauses shall be executed after terms and conditions.
17. The rates quoted should specify whether the same are inclusive of all services taxes.
18. Payment shall be made after tax deduction at source.
19. Bill shall be submitted by the agency immediately after the trip is over but not later than seven days in any case.
20. In case of any litigation the jurisdiction will be at Panchkula. In case of any dispute arising under the contract/agreement, the same shall be referred to the sole arbitrator appointed by Chairman, Haryana Staff Selection Commission. He/she may be the employee of Haryana Staff Selection Commission and the award of the Arbitrator shall be final and binding on the parties to the contract/agreement. The venue of Arbitration will be Panchkula and the proceeding of Arbitrator may be in English or Hindi.
21. The service provider, who shall succeed will not disclose the confidentiality of activity (examination process) and anything related thereof to anyone except

- only after the proper approval of the Commission and a non-disclosure undertaking shall have to be submitted to the Commission on the stamp papers.
22. The Commission reserves the right to reject/cancel/withdraw the tender without any reason at any time.
 23. Earnest money deposit will not carry any interest. The EMD deposited by unsuccessful bidder/tender will be refunded as soon as possible. EMD of successful tenderer will be refunded after successful tenderer finishes the agreement successfully.
 24. The contract/agreement will be governed by the applicable law in India for the time being in force.

The tender should be submitted by 23.01.2023 at 11.00 AM and the technical bid shall be opened on the same day i.e. 23.01.2023 at 03.00 PM. The Financial Bid will be opened after approval of technical bid. Date and time of opening of financial bid shall be intimated at the time of opening of technical bid. Further clarification, if any, needed may be taken from office within 3 days of issuance of tender notice.
